## ADDITIONAL INFORMATION ON THE MEMBERSHIP CATEGORY

### RENTAL MEMBER

Any Individual, Company, Limited Liability Partnership, or Partnership Firm that is registered with proper authority, and whose main core business is to provide services of AWP on a rental basis is eligible for membership as a Rental Member as the board may deem fit.

### DEALER MEMBER

Any Individual, Company, Limited Liability Partnership, or Partnership Firm that is registered with proper authority, who is an INDIA-registered dealer of any parts or machines related to AWP is eligible for membership as a Dealer Member as the board may deem fit.

Any Applicant member whose CORE business is that of a dealer and has a few machines on a rental basis is eligible in only this category.

\*Members in this category **do not have VOTING rights**





### LOCAL MANUFACTURER

Any Individual, Company, Limited Liability Partnership, or Partnership Firm which is registered with proper authority who is an INDIA-registered manufacturer of any parts or machines related to AWP is eligible for membership as a Local Manufacturer Member as the board may deem fit.

Any Applicant member, whose CORE business is that of manufacturing and has a few machines on a rental basis, will have to apply in this category

Any Indian Manufacturer having offices / representative offices outside of India shall be eligible as a Foreign Member.

### FOREIGN MANUFACTURER

Any Individual, Company, Limited Liability Partnership, or Partnership Firm that is registered with proper authority and has a registered address outside of INDIA is eligible for membership as a Foreign Member as the board may deem fit

Any India representative office for any Multi-National Company shall also be eligible in this category only.

### ASSOCIATE MEMBER

Any Individual, Company, Limited Liability Partnership, or Partnership Firm which is registered with proper authority who is not eligible in any of the above-mentioned categories, is related to the AWP industry is eligible for membership as an Associate Member as the board may deem fit
